Critical Review of
"Islamic Banking Preference: a Rasch Analysis"

Using questionnaires and Rasch model, this paper measures the community's preference on the Islamic banking attributes in Indonesia. Of the 18 Islamic banking attributes, assurance, friendliness, and the application of Islamic principles are viewed as the primary attributes. Other attributes are also considered as potential factors. The author(s) argue that the results are valid and fit the expected model.

What makes this study different from other similar papers that study the major attributes preference of customers in selecting the Islamic banks (Malaysia (Echchabi and Olaniyi, 2012), Pakistan (Ahmad at al., 2011), Bangladesh (Khan, Hassan and Shahid, 2008), Bahrain (Al Ajmi, Abo Hussain and Al Saleh, 2009), Turkey (Okumus and Genc, 2013), and Indonesia (Setiawan, Puspitasari and Manurung, 2015)) is that these previous studies have not used the Rasch model. This study contributes to the literature by studying the major attributes preference of customers in selecting the Islamic banks in Indonesia using the Rasch model. Bond and Fox (2015) stated that Rasch model is becoming the most appropriate model for basic measurement in the field of human sciences.

The authors have done a reasonable job in explaining the model used, the attributes considered to be measured, and the results. It still has major issues that need to be addressed.

1- The title "Islamic Banking Preference: a Rasch Analysis" reflects only part of the paper's content. Indonesia should be included in the title.

2- It may be useful if the authors compared their paper to Setiawan, Puspitasari and Manurung (2015) paper (e.g., Do the results contradict with each other or are they are they consistent; how does using the Rasch model make this paper different from the other papers). The authors need to show how their paper is different from Setiawan et al paper and what are the uniqueness of their paper.

3- It may be useful if the authors attached the questionnaires used to the paper as an appendix.

4- It may be useful if the authors explain the methodology used in plain and language.

5- It may be useful if the authors develop their argument in a way easier for the reader to follow.

6- It may be useful if the authors focused their analysis in the narrow scope of the paper and results rather than commenting in argument that do not have adequate basis (argument that are not supported by theoretical or empirical studies).

7- Tables I, II, and III are very well explained. Tables IV, V, VI, and VII require further analysis and clearer explanation and presentation.

8- It may be useful if the authors write a more precise and focused introduction. Needs better motivation and show their contribution in the introduction.

Overall, a good attempt. Kindly re-read the content of the paper and correct some grammatical typos. For example, in Introduction "Figure 1 Supply us" this shall be supplies....

At page 3 'Islam Principles' this shall be Islamic principles

At page 6 'Majorities of respondents' this shall be majority of....

At page 11 (Discussion) The service officer must be able to....., have willing, this should be 'willingness'

Additional Questions:

1. Originality: Does the paper contain new and significant information adequate to justify publication?: The paper reflects a good amount of efforts which has been poured in developing the argument. The paper is fine for publication provided a little more work is done to improve the quality of communication. The introduction section is based on a general descriptive tone which can be further enhanced by bringing in an academic flavor.

2. Relationship to Literature: Does the paper demonstrate an adequate understanding of the relevant literature in the field and cite an appropriate range of literature sources? Is any significant work ignored?: The paper contains a sound level of reference to the relevant literature. The Section 'Literature Review' can be given some other heading such as 'Customer Preference Basis in Islamic Banking: an Overview' or any other suitable heading. In its current form, it seems part of a thesis/dissertation chapter.

3. Methodology: Is the paper's argument built on an appropriate base of theory, concepts, or other ideas? Has the research or equivalent intellectual work on which the paper is based been well designed? Are the methods employed appropriate?: The methodology of the paper is apparently grounded well.

4. Results: Are results presented clearly and analysed appropriately? Do the conclusions adequately tie together the other elements of the paper?: The results are presented and articulated well.

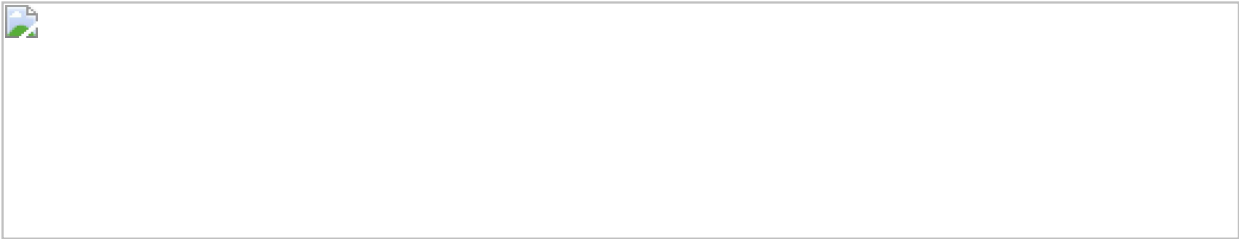
