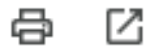

Reviewer 1: The paper aims to investigate the direct effect of Covid-19, and the interaction effect with corporate governance on bank performance. The scope is appropriate for **IJFBS**. However, panel data regression is presented to analyze the dataset. This methodology is applicable to deliver the findings exactly. The abstract should be revised by considering the items of structured abstract. So, I don't see any items for the "novelty" and "future expectations and studies" in the abstract. These items should be added to the abstract accordingly. In the introduction, the current developments and the importance of the selected topic should be also explained with the current data of the related determinants. Thus, it will be more understandable for the researchers. Another issue is regarding the literature. More outstanding references published in SSCI/SCI journals could be mentioned in the literature review. After that, the section of methodology should be given in detail. The analysis and the results are satisfactory. The final section could be reconsidered as "discussions and conclusion" and the results should be given with the supported references into the paragraphs.
